Effects include dry throat, metallic taste, chest pain, dyspnea, rales, and dry cough. Several hours later, chills may occur with lassitude, malaise, fatigue, headache, back pain, muscle cramps, blurred vision, nausea, fever, perspiration, vomiting, and leukocytosis.
